What is this product?

The product is a share of the sub-fund Templeton Global Climate Change Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

Term The Fund has no maturity date. The Fund could be closed under the conditions led down in the current prospectus of the Fund.

Objectives

Investment Objective

The Fund aims to contribute towards climate change mitigation and adaptation as considered by the Paris Climate Agreement while increasing the value of its investments over the medium to long term.

Investment Policy

The Fund pursues an actively managed investment strategy by investing in companies across all sectors worldwide that are good stewards of their impact on social and environmental development belonging to 3 categories: • solution providers (more than 50% of the Fund's net assets): companies deriving a majority of revenues from activities aiming at reducing carbon

emissions or improving resource efficiencies.
transitioning companies: companies making industry-leading efforts to reduce emissions or resource intensity.


• resilient companies: companies having relatively low carbon and resource intensity.

The Fund can invest to a lesser extent in:

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Morgan SE, Luxembourg branch. What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs.
