What is this product?

The product is a share of the sub-fund Templeton Asian Growth Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an openended investment company with variable capital (SICAV), qualifying as a

The Fund has no maturity date. The Fund could be closed under the conditions led down in the current prospectus of the Fund.

Objectives

Investment Objective

The Fund aims to increase the value of its investments over the medium to long term

Investment Policy

The Fund pursues an actively managed investment strategy and invests mainly in:

- equity securities issued by companies of any size traded on stock exchanges in Asian countries (excluding Australia, New Zealand and Japan)
- equity securities issued by companies of any size located in, or doing significant business in, Asian countries (excluding Australia, New Zealand and Japan)

The Fund can invest to a lesser extent in:

- equity or debt securities issued by companies of any size located in any country in the Asia region, including any other emerging markets in the Asia region
- equity securities of companies located outside of the Asia Region but which derive a significant proportion of their revenues or profits from the Asia region

The investment team uses in-depth financial analysis to select individual securities that it believes will provide the best opportunities for increased value over the long term.

The benchmark of the Fund is the MSCI AC Asia ex-Japan 10/40 Index-NR - Linked. The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. The Fund can deviate from the benchmark.

Share Class Policy

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

What are the costs?

Costs over Time
